Abortion

- Alabama: A parent must give consent for a minor to obtain an abortion.
- Alaska: No parental involvement requirement. The state's parental notification law is permanently enjoined by court order.
- Arizona: A parent must give consent for a minor to obtain an abortion.
- Arkansas: A parent must give consent for a minor to obtain an abortion.
- California: No parental involvement requirement. The state's parental consent law is permanently enjoined by court order.
- Colorado: A parent must be notified 48 hours prior to a minor obtaining an abortion.
- Connecticut: No parental involvement requirement.
- Delaware: For a minor under the age of 16, a parent must be notified 24 hours prior to a minor obtaining an abortion.
- District of Columbia: No parental involvement requirement.
- Florida: A parent must be notified 48 hours prior and give consent for a minor to obtain an abortion.
- Georgia: A parent must be notified 24 hours prior to a minor obtaining an abortion.
- Hawaii: No parental involvement requirement.
- Idaho: A parent must give consent for a minor to obtain an abortion.
- Illinois: No parental involvement requirement.
- Indiana: A parent must give consent for a minor to obtain an abortion.
- Iowa: A parent must be notified 48 hours prior to a minor obtaining an abortion.
- Kansas: Both parents must give consent for a minor to obtain an abortion.
- Kentucky: A parent must give consent for a minor to obtain an abortion.
- Louisiana: A parent must give consent for a minor to obtain an abortion.
- Maine: No parental involvement requirement.
- Maryland: A parent must be notified prior to a minor obtaining an abortion.
- Massachusetts: For a minor under the age of 16, a parent must be notified prior to a minor obtaining an abortion.
- Michigan: A parent must give consent for a minor to obtain an abortion.
- Minnesota: No parental involvement requirement.
- Mississippi: Both parents must give consent for a minor to obtain an abortion.
- Missouri: A parent must give consent for a minor to obtain an abortion.

- Montana: For a minor under the age of 16, a parent must be notified 48 hours prior to a minor obtaining an abortion. The state's parental consent law is temporarily enjoined by court order.
- Nebraska: A parent must give consent for a minor to obtain an abortion.
- Nevada: No parental involvement requirement. The state's parental notification law is permanently enjoined by court order.
- New Hampshire: A parent must be notified 48 hours prior to a minor obtaining an abortion.
- New Jersey: No parental involvement requirement. The state's parental notification law is permanently enjoined by court order.
- New Mexico: No parental involvement requirement. The state's parental consent law is permanently enjoined by court order.
- New York: No parental involvement requirement.
- North Carolina: A parent must give consent for a minor to obtain an abortion.
- North Dakota: Both parents must give consent for a minor to obtain an abortion.
- Ohio: A parent must give consent for a minor to obtain an abortion.
- Oklahoma: A parent must be notified 48 hours prior and give consent for a minor to obtain an abortion.
- Oregon: No parental involvement requirement.
- Pennsylvania: A parent must give consent for a minor to obtain an abortion.
- Rhode Island: A parent must give consent for a minor to obtain an abortion.
- South Carolina: For a minor under the age of 17, a parent must give consent for a minor to obtain an abortion.
- South Dakota: A parent must be notified 48 hours prior to a minor obtaining an abortion.
- Tennessee: A parent must give consent for a minor to obtain an abortion.
- Texas: A parent must be notified 48 hours prior and give consent for a minor to obtain an abortion.
- Utah: A parent must be notified 48 hours prior and give consent for a minor to obtain an abortion.
- Vermont: No parental involvement requirement.
- Virginia: A parent must be notified 48 hours prior and give consent for a minor to obtain an abortion.
- Washington: No parental involvement requirement.
- West Virginia: A parent must be notified 48 hours prior to a minor obtaining an abortion.

- Wisconsin: A parent must give consent for a minor to obtain an abortion.
- Wyoming: A parent must be notified 48 hours prior and give consent for a minor to obtain an abortion.
