

Stealth Agenda Report

Biden Administration:

April 27, 2022—At a White House Teacher of the Year event, Biden said, "They're not somebody else's children; they're like yours when they're in the classroom."

June 29, 2022—Biden's Department of Agriculture announced that it would withhold money from school lunch programs unless the schools can specify in their policies that discrimination based on gender identity and sexual orientation is prohibited, such as allowing transgender students to use the bathroom of their "preferred gender." Frequently when schools allow for this accommodation, they do not inform parents that this policy is on the books.

June 29, 2022—Biden's Department of Health and Human Services (HHS) is encouraging those seeking legal information about abortion in their state to visit AbortionFinder.org. On this website, there is a section that offers help finding a judicial bypass to those under the age of 18 so they do not have to involve their parents. AbortionFinder.Org partners with Planned Parenthood, the National Abortion Federation, and Advancing New Standards in Reproductive Health.

July 14, 2022—Biden's CDC is encouraging LGBT youth to engage with Q Chat Space. This online chat space, where youth can discuss sex, polyamorous relationships, the occult, sex change operations, and activism, is designed with a "quick escape" feature so it can intentionally be easily hidden from parents.

July 18, 2022—Biden's CDC also partners with the Gay, Lesbian, Straight Education Network (GLSEN). This leftwing-activist organization seeks to embed the tenets of gender ideology into classrooms across the country often behind the backs of parents.

November 13, 2022—HHS Assistant Secretary Rachel Levine, a man pretending to be a woman, has a long track record of promoting transgender procedures for minors. When parents could not learn to what degree the Pennsylvania Department of Health was involved in supporting gender clinics in public schools in the Philadelphia area, they filed a Right-To-Know request. It then came to light that while running the department Levine showed great interest in any scientific data that supported minors undergoing "bottom surgery." Levine has repeatedly stated that the Biden administration, including "people at the highest levels," support these procedures.

Education:

May 22, 2021—A male student identifying as transgender raped a girl in a women's restroom in a Virginia school. The administration never called the sheriff's office and worked to conceal the incident by transferring the rapist to another school where he once again sexually assaulted another girl. Administrators feared if this crime had become public knowledge it would have derailed their secret policy of allowing students to use restroom and locker facilities based on their "gender identity."

September 29, 2021—The National School Boards Association sent a letter to the Biden administration accusing parents of being domestic terrorists because the parents were outraged by the discovery that schools across the nation have been stealthily promoting Critical Race Theory (CRT) and gender ideology while maintaining draconian Covid-19 protocols.

July 27, 2022—Linn-Mar Community School District in Iowa allows students in 7th-12th grades to create a "Gender Support Plan" to make arrangements "regarding names/pronouns, restroom and locker facilities, overnight accommodations on school trips and participate in activities." Parents are not notified unless their child wishes for them to know.

August 14, 2022—The Michigan Department of Education (MDOE) trained teachers to hide students' "preferred pronouns" and name changes from their parents. Kim Phillips-Knope, project lead for the MDOE LGBTQ Student Project, said in a video shown during the training that "Schools don't have a legal obligation to tell parents that a student goes by a different name or pronouns than their legal name."

August 15, 2022—Schools across the country have used the Biden administration's change to Title IX to hide information on children's "sexual orientation" and "gender identity" from their parents. For instance, an Alaskan school allowed a girl to go by a boy's name and changed every school record except for those sent to her parents to reflect the new name. When the girl's mother found out, she called the school and was told that Title IX prevented the school from informing her.

September 5, 2022—Schools across the country are promoting social and emotional learning (SEL). While it sounds innocuous, SEL promotes leftwing indoctrination and is closely related to CRT. Often SEL curriculum is inserted without parents being aware that it is being taught.

October 11, 2022—Public school libraries in Dearborn, MI, offered *This Book Is Gay* to students. The book provides graphic instructions on "handies," "blowies," and "sex apps." When the predominant Muslim community organized to ban this book and others they found objectionable, the American Federation of Teachers, run by Randi Weingarten, opposed the parents efforts and called for the book to be reinstated.

Healthcare:

September 5, 2022—Lurie Children's Hospital of Chicago partnered with local schools to promote radical gender theory, "kink," and "trans-friendly" sex toys for children as young as 11-years-old. The hospital also works with the schools' "Gender Support Coordinators" to facilitate sex and gender transitions for students, which under the confidential policy in place can be done behind the backs of the parents. This essentially creates a pipeline where children learn about LGBT issues in school and the school can refer them to Lurie Children's Hospital while keeping it secret from their parents.

September 15, 2022—The World Professional Association of Transgender Health (WPATH) issued new guidelines on how to treat minors with gender dysphoria. While WPATH recommends that parents should be included in the transition process, the guidelines, however, note they could be omitted if "their involvement is determined to be harmful to the adolescent." Particularly, parents should be left out if they are "too rejecting of their adolescent child and their child's gender needs." One WPATH author went as far as suggesting that practitioners could call Child Protective Services on parents reluctant to transition their child.

January 5, 2023—Not only does Sanford Health provide transgender healthcare, but it also employs nearly seven times more South Dakotans than any other business in the state giving the medical conglomerate significant political power. Sanford has been able to use its influence to shape state laws to promote transgender causes. It has killed legislation that would expand the conscience rights for medical practitioners, prohibit sex-change procedures and drugs for children, compel students to use bathrooms and locker rooms that correspond to their sex, require that teachers inform parents when students express feelings of gender dysphoria, and establish the "fundamental" parental right "to make decisions concerning the upbringing, education and care of a child."
