The Center for Health and Human Rights works to improve health through academic research that focuses on the nexus of health and national and international human rights law. Mission Statement

"In order to advance justice and the common good, CSJ promotes and integrates community-based research, teaching and service by collaborating with diverse partners and communities.

"CSJ is guided by that mission as it strives to consolidate and develop work in its three key areas: community and public service, curriculum and pedagogy, and engaged research. The Pathways to Social Justice Curriculum

Mission Statement

"Georgetown's Pathways to Social Justice (PSJ) curriculum prepares students to critically analyze historical and contemporary power differentials. A cornerstone of this requirement is the one-credit University Seminar in Race, Power, and Justice, which is designed to ensure that every student at Georgetown develops a baseline vocabulary for discussing racial difference and marginalization. This seminar will provide the foundation for each student's engagement with other PSJ-attributed 'overlay' courses offered across Georgetown's Main Campus. Starting in Fall 2024, every Georgetown student must take two three-credit PSJ overlay courses prior to graduation.

"By fulfilling the Pathways to Social Justice requirement, students will gain a better understanding of how social, political, geographic, economic, and other cultural factors shape experiences of the world, as well as how these factors contribute to marginalization and inequality. PSJ courses will also explore how communities have resisted marginalization, and will focus on axes of identity that have formed the basis for historical and contemporary marginalization and oppression, including race, gender, class, caste, disability, religion, sexual orientation, and gender identity."

Alternative Breaks Program

The Alternative Breaks Program (ABP) brings together Georgetown community members in order to foster intersectional solidarity and inspire lasting commitments to service and social justice. ABP trips engage with diverse and vibrant communities through direct service, immersion, and reflection in a substance-free environment. By creating a space for sustained dialogue and action, ABP strives to build long-term relationships with community partners and bring the experience home.

Social Justice Curriculum Infusion

CSJ staff members welcome the opportunity to meet with GU community members, including faculty and staff, to discuss ways in which social justice themes, speakers and inquiries can be infused into a wide spectrum of courses and programs. CSJ can offer pedagogical, assessment and content-based resources as well as provide introductions to appropriate social justice speakers and partners locally and globally.
